

A AND C PACKERS WEBSITE TERMS OF USE

Parties, Obligations and the Website

1. The aandcpackers.com.au website ("Website") is owned and operated by the A and C Packers Pty Ltd (ABN 12 009 793 551) ("A and C Packers").
2. Access to the secure areas of this Website is restricted to persons who are authorised customers of A and C Packers. Access by unauthorised persons is strictly prohibited.
3. By accessing, browsing and/or using this Website, each Customer is expressly agreeing to abide by the terms and conditions referred to in this document ("Terms of Use").
4. Each Customer should read the Terms of Use prior to using this Website.
5. Although A and C Packers may notify Customers of a change in the Terms of Use it is under no obligation to provide such notice and reserves the right to amend the Terms of Use at any time without notice.
6. It is the Customer's responsibility to read and be familiar with the Terms of Use.

General Commercial Terms

7. This Website is provided for the purposes of allowing the Customer to do the following with an industry standard browser:
 - a) access as presented on this Website information about A and C Packers, the terms of the relationship between A and C Packers and the Customer, and the goods and/or services presented on this Website; and

The Customer must use this website solely for the above authorised purposes.

8. Upon registration and the opening of an account with A and C Packers, A and C Packers will authorise the Customer to become a Registered User. Customers will be notified once their A and C Packers account has become fully activated.
9. Registered Users will have access to secure areas of the Website and may check account details about A and C Packers goods and/or services presented on this Website.

Prices and Products are subject to Change

10. All prices, products and services displayed on this Website and offered by A and C Packers are subject to change without notice. It is the responsibility of the Customer to check the price of a product or service before placing an order for it.

Customer Responsibilities

11. The Customer must:
 - a) use this Website in accordance with the Terms of Use;
 - b) if under the age of 18, obtain a parent or guardian's consent prior to using the Website;
12. The Customer is responsible for maintenance and supply of all their own hardware and software used to access the Website and the Internet.
13. The Customer must not:
 - a) use the Website to post or transmit any information or materials in breach of any laws or regulations;

Notice given to A and C Packers does not release the Customer from the Terms of Use.
- 19. In the event of an unauthorised use, A and C Packers will take reasonable steps to deactivate the Customer's Account and issue the Customer with new membership details within a reasonable time.

The collection and provision of collected information is subject to privacy laws and A and C Packers will comply with its Privacy Statement in dealing with any personal information.
- 21. A and C Packers may release to an Authorised Person information collected by A and C Packers from the Website.

Suspension and Termination

41. The Customer may stop using the Website at anytime, for any reason.

42. A and C Packers may immediately suspend or limit the Customer's access to the Website if:

a) the Customer is in breach of the Terms of Use and the breach in cannot be remedied or the customer has failed to remedy breach within thirty (30) days of being notified of the breach;

b) A and C Packers has reasonable grounds to believe that there is a real risk of loss or damage to us or another party unless A and C Packers suspends or limit usage;

c) the law requires A and C Packers to do so;

d) access to the Website becomes illegal;

e) the Australian Competition and Consumer Commission issues a competition notice relating to the Website or A and C Packers has reasonable grounds to believe it will do so; or

f) there is an emergency.

43. The Terms of Use are effective until terminated by A and C Packers.

44. A and C Packers may terminate this agreement and the Customers Access to the Website at anytime without notice.

45. In the event of termination, the Customer is no longer authorised to access the Website, but all restrictions, disclaimers and limitations of liability remain enforceable.

46. Termination will not affect any legal right that may have accrued to A and C Packers against the Customer up to the date of termination.

48. If any of the terms in this Terms of Use are invalid for whatever reasons, they will be struck out and the remaining terms will remain in force.

49. A failure by A and C Packers to pursue a breach of the Terms of Use by the Customer does not waive any rights A and C Packers has to pursue the Customer for a similar or subsequent breach.
